OAT Background

The City of Phoenix created the Office of Accountability and Transparency (OAT) in 2021 to perform independent civilian oversight of the Phoenix Police Department (Department). OAT reviews Department administrative investigations of critical incidents involving sworn personnel and provides community members a way to freely communicate complaints, commendations, and concerns about officers and the Department without fear of retaliation.

Phoenix City Code (P.C.C.) § 20-1(C) requires OAT to:

- Take community complaints or commendations.
- Establish procedures for receiving anonymous complaints.
- Conduct outreach within the community.
- Support services to community members impacted by the Department.
- Review Department investigations.
- Make recommendations to the Police Chief regarding policy rules and training issues.
- Conduct mediation to resolve disputes.
- Administer a youth outreach program.
- Address other issues of concern to the community.

See P.C.C. §§ 20-4 through 20-26 for additional information about OAT's responsibilities and operations. Chapter 20 was revised in May 2024 and codified in September 2024.

During the first quarter of 2025, OAT and the Department revised their Memorandum of Understanding (MOU). Changes included the establishment of 72-hour disclosure timeframes, updates to document and information sharing practices, and the addition of sections regarding the Civilian Review Board and mediation. The full MOU can be found here.

P.C.C. § 20-8 requires OAT to publish annual and quarterly reports that include, among other things, the work of OAT during the prior calendar year; trends regarding complaints and investigations; recommendations for changes to policies, rules, and training; and policy rules or training revisions implemented by the Department. This report covers OAT's first quarter updates (January 1 through March 31).



Review Reports

Cases that OAT reviews come from complaints filed by the public, media reports, and Department notifications for certain types of incidents (e.g., officer involved shootings). During the first quarter of 2025, OAT added 18 cases to its review caseload, bringing its active review caseload to 131.

OAT released two review reports in the first quarter of 2025. Both reports reviewed Department investigations of officer involved shootings, one of which resulted in a civilian fatality. After review, OAT concluded that one of the two investigations was thorough and complete. Both reports included recommendations to improve future administrative investigations. All review reports can be found on the OAT <u>website</u>.

Between January 1 and March 31, 21 community members contacted OAT via phone (15), email (2), and walk-in (4). See Figure 1 below.

Figure 1: OAT Q1 Contacts by Type, September 1, 2022, to March 31, 2025



Figure 2: OAT Review Cases by Incident Year and Quarter, September 1, 2022, to March 31, 2025







Figure 3: OAT Review Cases by Incident Year and Type, September 1, 2022, to March 31, 2025








Figure 4: Map of OAT Review Cases by Department Precinct[†]



Civilian Review Board

The Civilian Review Board was established by the Mayor and City Council in May 2024. Following an application process, the nine members were appointed by the Mayor with a majority vote by Council in October 2024. The Board is charged with reviewing OAT review reports and recommendations to the Department along with Department responses to the OAT review reports.

After reviewing an OAT report and the Department's response, the Board votes to adopt or decline OAT's completeness and thoroughness conclusions and accept, decline, or revise OAT's recommendations for future Department administrative investigations. The Board can also request additional information before making a final decision. The Board

will begin reviewing OAT reports and Department responses in the summer of 2025.

The Board held three meetings between January 1 and March 31, during which members received training on:

Training will continue into the second quarter of 2025.



Mediation

In the first quarter of 2025, OAT's Mediation Director continued educating members of the public and Department about mediation and its benefits, while also eliciting input to foster participation and success. OAT continued working with Department leadership on draft protocols outlining the types of community complaints that will be eligible for individual officers to take advantage of OAT mediation and how those will be tracked and communicated between OAT and the Department. OAT's Mediation Director led the first meeting of a newly created national network of similar community-police mediation programs.

OAT will eventually facilitate two types of mediation: department mediation and individual officer mediation. Department mediations are available for complaints where no individual officer is identified or incidents involving community concerns about police response, involvement, or broader police policy and practice. OAT continued working with Department leadership on the requirements and protocols for individual officer mediations for specific complaints against individual officers. OAT is also working through the procurement process to generate a pool of professional mediators who will facilitate mediation sessions between officers and civilians. Community Engagement

The OAT Community Engagement team tabled 23 events between January 1 and March 30, 2025, including:

OAT staff also gave 9 informational presentations and conducted 18 meet-and-greets and made more than 56 new community engagement contacts via phone, email, and inperson meetings. As a result of this work, OAT recorded more than 3,100 community member encounters in the first quarter of 2025.

This quarter, the OAT Community Engagement Team began developing a youth outreach program to educate, equip, and empower youth regarding law enforcement interactions,



civic responsibility, and community advocacy to promote equitable policing practices for youth. The pilot program will launch later this year.

Hiring

In March 2025, OAT onboarded three new staff to the monitoring team: two senior monitors and one monitor. OAT ended the first quarter of 2025 with 13 of its 15 positions filled (one OAT team member was serving in two roles at the end of the quarter). 


Figure 5: OAT Organizational Chart

Appendix B: OAT Mediation Information

The Phoenix Office of Accountability and Transparency (OAT) aims to ensure there is a fair, thorough, and objective program for addressing civilian complaints against the Phoenix Police Department (PPD). While OAT reviews PPD internal investigations, such investigations are not the only method by which complaints may be resolved. In many cases, mediation may provide a more satisfactory outcome for the parties. Mediation has been shown to help build police-community relations, reduce costs, improve case completion times, and provide community members an opportunity to meet directly with a member of the PPD about the nature of their complaint.

Mediation is Confidential

All discussions during a mediation session are confidential, in accordance with ARS § 12-2238. All parties must agree to this confidentiality before beginning a mediation session. As a result, the participation of other people in the mediation session is very rarely allowed. Unless preapproved to participate in the mediation, anyone who accompanies a complainant or PPD to the mediation session will be asked to wait in the OAT lobby.

Mediation is a Voluntary Process

Participation in mediation is voluntary. Either party may decline the offer to mediate or withdraw from mediation at any point.

Mediation Participants

Both the complainant and the PPD officer must participate in good faith in the mediation process. Neither the complainant nor the PPD officer is required to reach an agreement during mediation. Failure of the complainant to participate in good faith will lead to dismissal of the complaint. Failure of a PPD officer to participate in good faith will likely result in the matter being referred back to investigation, unless otherwise specified in the PPD officer's labor-management agreement.

OAT Mediators

OAT mediations are conducted by well-trained and experienced mediators. The mediator serves as an impartial third party who facilitates a conversation between the parties in a non-threatening environment. Mediators fulfill this role by listening to each party's experiences of circumstances that lead to the complaint. Mediators use active listening to clarify what happened, identify key issues and keep the discussion productive.

WHAT IS OAT MEDIATION?

Mediation is an efficient and effective alternative dispute resolution process. OAT mediations arise from incidents or interactions reported to OAT involving PPD and members of the community. An OAT mediator serves as an impartial facilitator who guides the parties through a conversation about the circumstances that led to the complaint, with the aim of reaching a mutual understanding. A mediation is typically scheduled for two hours.

Mediation Outcomes

In many cases, once the parties have had a chance to explain their perspectives and hear from the other party, this increased understanding is sufficient to resolve the complaint. Although both parties are expected to participate in good faith in the mediation, any agreements, written or verbal, are voluntary. Failure to reach an agreement has no impact on any later consideration of the complaint. If the parties do not reach agreement, OAT will determine if the complaint warrants referral for investigation.

Accessibility

Upon request, OAT will provide reasonable accommodation or translation services.
