## **Community Budget Questions Summary April 1-17, 2020**

## **Summary**

Each year, staff tracks comments on the City's budget. The City Manager's Trial Budget was scheduled to be presented to the City Council on March 17, 2020, with budget hearings scheduled to begin April 2, 2020. However, due to current restrictions on public gatherings, the city unfortunately had to cancel normal and customary community budget hearings and the Trial Budget is being revised due to the economic downturn.

Based on the revised budget adoption schedule discussed at the March 26, 2020 City Council Policy Session, staff returned with additional information on April 2 and April 6 to walk the City Council through four different budget scenarios modeling the impact of COVID-19 on our General Fund revenues. On April 13, staff presented the 2020-21 Revised Trial Budget, focusing on the city's proposed response efforts to the current economic downturn caused by the COVID-19 public health crisis. We very much value the feedback and community engagement received in our community budget hearings. Unfortunately, this year it will be necessary to use a different format and a compressed schedule to accomplish this goal.
