KEY DATES FOR NOVEMBER 5, 2024 REGULAR COUNCIL ELECTION FOR MAYOR AND DISTRICTS 1, 3, 5 & 7

Candidate Packet

- ★ **January 2024:** Available on phoenix.gov/elections. Candidate packet review meeting with City Clerk staff available upon request by calling: 602-262-6837 or e-mailing: phoenixelections@phoenix.gov.

Candidate Statement of Interest Form

- ★ **Due BEFORE collecting nomination petition signatures:** Must be filed with the City Clerk before signatures are collected, otherwise signatures are invalid. Form available in the Candidate Packet. A.R.S. 16-311 (H)

Candidate Nomination Petition Signatures

- ★ **May 9, 2024 - July 8, 2024:** Signatures may be collected no earlier than 180 days prior to the election. Signature requirements: For Mayor: 1,500 signatures of registered voters in Phoenix. For a Council Member: 200 signatures of registered voters residing in that District. *City Charter, Chapter XII, Sec. 2*

Candidate Nomination Papers Filing

- ★ **June 8, 2024 - July 8, 2024:** Nomination papers & petitions with signatures must be filed with the City Clerk. A.R.S. 16-311(B); A.R.S. 16-341 (C)

Ballot Language

- ★ **By June 8, 2024:** Deadline for City to submit ballot language (for propositions) to the County.

Candidate List Certification

- ★ **By July 18, 2024:** Deadline for City Clerk to certify the list of candidates for the ballot and send list to the County. *City Charter, Chapter XII, Sec. 7*

Candidacy Withdrawal

- ★ **By 5PM on July 19, 2024:** Latest date for candidate to withdraw their candidacy.

Proposition Arguments

- ★ **By August 7, 2024:** Deadline to submit Pro/Con Arguments for ballot measures to the City Clerk. *City Code Sec. 12-403*

Write-in Candidates

- ★ **By September 26, 2024:** Deadline for write-in candidates to file with the City Clerk. *City Code Sec. 12-1103*

Publicity Pamphlet

- ★ **September 30, 2024:** Publicity Pamphlet mailing begins. A.R.S. 19-123 (B) & *City Code Sec. 12-403*

Voter Registration

- ★ **By October 7, 2024:** Deadline for voters to register to vote in the November 5, 2024 election. *City Code Sec. 12-106; A.R.S. 16-120(A)*

Early Ballots

- ★ **October 9, 2024.:** Early ballot mailing begins. A.R.S. 16-542(C); A.R.S. 16-544(F)

Early Voting

- ★ **October 9, 2024 - November 1, 2024:** Persons can vote early by mail or in person on the 15th Floor of City Hall. *City Code Sec. 12-907; A.R.S. 16-542*

Election Day

- ★ **November 5, 2024:** County-conducted Election. A.R.S. 16-204

Canvass of the Votes

- ★ **November 20, 2024:** Estimated date the City Council will canvass the votes and certify the election results. *City Charter, Chapter XIII, Sec. 1*

Runoff Election (if any)

- ★ **March 11, 2025:** If no single candidate receives a majority (50% plus 1) of the votes for an office in the November 5, 2024 election, the top two candidates that received the most votes will advance to a runoff election conducted by the City. *City Charter, Chapter XII, Sec. 16*

Candidates Start Term of Office

- ★ **April 21, 2025:** Candidates that obtained the majority (50% plus 1) of the votes for an office in the November 5, 2024 election, OR won in the March 11, 2025 Runoff Election, if any, begin their term the 3rd Monday in April after the election. *City Charter, Chapter III, Sec. 6*
