- **Recommendation 2.8:** Some form of civilian oversight of law enforcement is important in order to strengthen trust with the community. Every community should define the appropriate form and structure of civilian oversight to meet the needs of that community.

- **Audit / Monitor**
- **Investigations**



# REVIEW

- **Reviews Investigations Conducted By Police Dept**
- **May Make Recommendations About Discipline**
- **Makes Recommendations For Policy Changes**



# AUDIT / MONITOR

- **Reviews Data To Determine Patterns Of Concern**
- **Monitors Investigations To Ensure Fair And Impartial Procedures Were Used**
- **Makes Recommendations For Operational Changes**




# INVESTIGATIONS

- **May Have Full Independence To Conduct Parallel Investigations**
- **May Or May Not Have Subpoena Authority To Compel Testimony**
- **May Or May Not Have Disciplinary Authority**
