Peterson, Maricopa County Public Defender's Office (620 W Jackson Street, Suite 3076, Phoenix, AZ 85003); Jury Trial, September 2014
 I represented the State of Arizona as sole counsel in a felony burglary trial to a jury. The defendant was found guilty at trial by the jury.

The defendant and co-defendant were found exiting the yard of the victim's home and were in possession of financial documents and property that the victim testified were taken from the home. The case was especially complex as it involved an immunity agreement, the assertion of an alibi defense, significant circumstantial evidence and the impeachment of the defendant who testified in his own defense. The case was appealed (citation provided above) and the Arizona Court of Appeals reviewed my conduct during the trial and found it within the rules of evidence and ethics. A subsequent review for post-conviction relief made the same determination. The case was one of my early felony trials and required significant preparation and use of the rules of criminal procedure and evidence.

State v. Newton, Phoenix Municipal Court Case No. 20228000848, Hon. Alex Navidad; Defense Counsel: Stephanie Ehrbright, 300 West Washington Street, Phoenix, AZ 85003; DUI fatality case, Defendant plead guilty to the court, June 2023

I represented the State in a case that involved a DUI accident that resulted in a fatality. The defendant had previous DUI convictions and was driving while under the influence of THC and turned in front of the victim that directly caused the victim's death in the collision. The case was extremely emotionally charged for the victim's family and required many conversations with the victim's family about the criminal process. This case would have been a very complex DUI to try to a jury had the matter proceeded to trial. This case highlights the delicate and difficult nature of representing the State in THC DUI cases but as important, being empathetic and stalwart in pursuing justice for victims. The defendant was sentenced to the maximum penalty for the offense by the judge at a lengthy sentencing hearing.

- State v. Wenzl, Phoenix Municipal Court Case No. 100517666, Hon. Cynthia Certa; Defense Counsel: Charles Franklin, 8901 E Pima Center Pkwy, Ste 115, Scottsdale, AZ 85258; Jury Trial, March 2024 I represented the State in this DUI case. The defendant was found in the middle of the street in an intoxicated state. Officers tried numerous times to rouse the defendant and when he finally woke up, the defendant pushed a police vehicle out of the way and drove about a mile down the road before stopping. Due to health reasons, police were unable to extract blood from the defendant and the case proceeded to trial without the benefit of a chemical test to establish what substances were impairing the defendant. The defendant was found guilty by the jury at trial, but due to misconduct by a juror, a new trial was ordered. The defendant was found guilty again at the second trial after a significant delay in motion litigation between the two trials.

The defendant was under the influence of a common opioid that is not banned in Arizona or the United States known as kratom. The case was also very challenging given the administration of prescribed medication to the defendant at the hospital after the collision. The defendant was found guilty by the jury at trial.

I represented Graham County in this matter brought to recover property taxes. The plaintiffs argued that Graham County had committed an error in the assessment of their commercial property because the property hosted low-income housing units that should have been considered in the assessment. Graham County took the position that the error was on the plaintiffs side for failing to notify the County of the status of the property. I participated in preparing the pleadings in the case including dueling motions for summary judgment. I also argued the case to the tax court judge and wrote the appellate brief when the Superior Court ruled against the County. Before the appeal could be heard on its merits, the case was settled out of court. Up until my participation in this case, I had very little litigation experience beyond criminal cases. I worked hard to make myself competent in tax matters and litigate against much more experienced attorneys.

I am the privileged descendant of poor immigrants who recently came to this country seeking opportunity, often facing hardship, discrimination, and economic instability. Their perseverance instilled in me a strong work ethic and a respect for the legal system that safeguards opportunity and justice. My upbringing gave me a firsthand understanding of how socioeconomic struggles can affect individuals and families - knowledge that can't be learned in textbooks alone. During my college years, I took a break from my studies and spent two years serving impoverished communities in South America. There, I witnessed what justice looks like when systems fail the most vulnerable and I came to deeply appreciate the importance of a fair and functioning judicial system. That experience strengthened my belief that access to justice must be equitable, and it taught me compassion for people navigating life while facing personal and societal adversity and economic and political instability.

Members of my own family have faced a range of serious challenges - including abuse, depression, poverty and addiction. My closeness to those experiences has broadened my understanding of the suffering of others and has deepened my empathy. They remind me daily that every individual who appears before the court brings with them all their life experiences and that they deserve to be treated with dignity and respect.

My path to a legal career began in a courtroom in high school. As part of a community service requirement, I chose to participate in a "Teen Court" where a juvenile judge would allow students to act as prosecutors, defense attorneys and jurors and call witnesses, present evidence, and make arguments. By chance, I was chosen to be a prosecutor. We presented a real case to the judge where a real young person would be have their crime adjudicated. At the end of the trial, the judge called me up to the bench and asked what my plans were after high school. Of course, I wasn't really sure at the time. And what the judge said next changed my life: he said that I should consider law school based on what he had seen of me in court that day.

Since then, I have spent the majority of my career inside a courtroom. I am extremely passionate about the value that a stable and fair justice system adds to our society. We live in a time where confidence in the justice system has waned. A great judge is the type of person that brings passion for the law, expertise in the rules of procedure and evidence, and compassion and respect for every person that enters into the courtroom. A great judge also lives their life and administers justice according to the highest ethics. I have striven to develop those qualities and I am convinced that I would be a judge that would help to strengthen the confidence in the justice system that we need right now.
