I also appeared before the Arizona Court of Appeals for Division One in 1995, on a juvenile appellate brief I wrote and then argued.

- State v. Michael Daw CR97-000212. Approximately 1997 in Mohave County. I was co-counsel with Steve Wiggs. The defendant was the Mohave County Public Fiduciary and he was accused of embezzling approximately \$875,000 from his vulnerable wards over whom he had guardianship and conservatorship to support his gambling addiction. After realizing the strength of the State's case, he pled guilty and was sentenced to ten (10) years in prison. Retired Judge Steve Conn of Mohave County Superior Court presided over the proceedings. The defense attorney was Lee Novak, 212 N. 4th Street Suite 2. Kingman, AZ 86401. 928-718-1700. This case was significant because as the appointed public fiduciary, he was in a position of trust over the most vulnerable people, and he exploited that trust by stealing their funds, some of whom had no money left after his embezzlement. Public corruption cannot be tolerated.

State v. Rudy Rodriquez. Th trial occurred in 1991 in Maricopa County Superior Court. CR1991-003520-001. This was my second trial as a prosecutor. Retired Judge Bernard Dougherty presided over the trial and defense counsel was Phil Vavalides, who no longer practices in Arizona. His last contact information is 4307 Shoal Creek Drive Greensboro, N.C 27410-8669. My maiden name was Hearn when I tried this case and the Daugherty trial. The defendant was charged with three counts of Armed Robbery. He robbed an elderly Chinese couple on three different dates at gun point at their store. He was convicted and ordered to serve 27 years in prison. This case was significant because the charges were serious, and because the victims were very fearful of the defendant, as he lived near their market in South Phoenix and they were afraid he would retaliate. I helped them feel comfortable testifying. They bravely told their story through a Chinese interpreter. It was my longest trial as a prosecutor, lasting two weeks. The conviction was affirmed on appeal.

- State v. Jean Owens 1991 in Maricopa County Superior Court. The defendant was a 60 year old woman charged with pointing a gun at a woman in a bank parking lot. Since it was charged as aggravated assault, a class 3 dangerous felony, a prison of 5-15 years was mandatory after trial. This case was significant because I fought to have the prison mandatory enhancement dismissed. The defendant had no prior record, and I felt strongly that the State should drop the allegation of dangerousness, making her probation eligible after trial. Prosecutors must do justice, and I felt that would be a just result and prison would not. This went against the policy at the County Attorney's Office at the time. After my impassioned discussion with my supervisor, he permitted me dismiss the allegation. While I had only practiced law for one year, my adversary had practiced law over thirty (30) years. The jury convicted the defendant, and she was able to receive probation, which was the appropriate result. Retired Judge Bernard Dougherty presided. Larry Debus (now deceased) and Tracey Westerhausen were opposing counsel. Ms. Westerhausen ai now a superior court judge with me.
- State v. Denise Daugherty. CR1991-00271-001 in Maricopa County Superior Court. This was my first trial as a prosecutor. The defendant was charged with pandering and keeping a house of prostitution. The case was significant because a corpus issue came up in trial and I was successfully argued it, and the conviction was affirmed on appeal. It was also significant as not many female defendants had been charged with running a house of prostitution during this timeframe. Retired Judge Ted Noyes presided, and Jeff Ross was the defense attorney. He can be reached at 602-953-9110. His address is Budoff & Ross 801 N. 1st Ave, Suite 21-553 Phoenix, AZ 85012. State v. Tom Dale Smith. P-1300-CR95-0315. I handled this case from 1995-96. The defendant had been a CNA, certified nursing assistant. He worked at a nursing home in Yavapai County. He physically abused several elderly and frail female residents. With one of them, he forced the 90-year old's contracted legs apart to clean her, causing one of her legs to break. Another one of the residents had long gray hair, and he picked her up by her ponytail to move her around which caused her to scream out in pain. With another resident, the defendant stuffed a feces covered washcloth in her mouth so she would stop talking. He pled guilty to vulnerable adult abuse and was sentenced to eight (8) years in prison. This case was significant because these very vulnerable, elderly female residents could not defend themselves and it was rewarding to try and provide them a measure of justice. I was always passionate about vulnerable adult abuse cases because they were so defenseless, and they need someone to be their voice and to protect them. The family of the woman with the broken leg wrote me a very heartwarming thank you note after his sentencing. Judge Kiger, Yavapai County Superior Court, handled the proceedings, and Arlene West was the defense attorney. Ms. West practiced in California, possibly Oakland, and was of counsel here.

State v. David Gordon CR2022-141671-001. July 2024. The prosecutor was Bernita Clark and the defense attorney was Victoria Washington. He was charge with Second Degree Murder, a class 1 dangerous felony, for shooting and killing his boss. I wrote a ruling on the constitutionality of his misconduct involving weapons charge which was severed for trial. He was convicted and sentenced to 25 years in prison. The appeal is pending. This case was significant due to the serious nature of the charges and the evidentiary issues which arose before and during trial. I have presided over other murder trials, however, this is the most recent.

State v. Robert Lee, CR2024-006141-001. The trial was held in October 2024. The prosecutor was Maggie Toth and the defense attorney was Michael Rothman. The defendant was charged with several counts of sexual conduct of a minor for molesting his stepdaughter, starting at the age of 9, and for sexually abusing her teenage friend. He was convicted on all counts. Given the age of his victim, he had to be sentenced to life in prison on two of the counts, and to lengthy consecutive prison sentences on the remaining counts. This case is significant due to the nature of the charges and the evidentiary issues which arose in dealing with both DNA testimony and an expert witness in child molestation cases. I have presided over many similar trials. His appeal is pending.

State v. Adan Orduno CR2011-156533-002 and CR2012-158171-001. He had three open felony cases with serious charges, including one with multiple counts of aggravated assault as his co-defendant shot at police as they were fleeing an armed robbery. I presided over two of his trials. After he was convicted in two of them, the State agreed to dismiss the third case. These cases are significant because with two trials there were several evidentiary issues, and his conduct required me to maintain my composure, which is an essential quality for a judge. During his second trial he threw water on me while on the witness stand. He admitted later that he assaulted me in hopes of stalling his prison sentence. The defendant also yelled at the top of his lungs during his entire sentencing, and my calm judicial demeanor allowed me to not be rattled. Finally, my even-keeled judicial temperament was needed many times as the two lawyers battled out the cases. April Sponsel was the prosecutor, and David Lockhart was the defense attorney. See Attachment A.

State v. Walsh CR2013-001171-001-005. This case involved a mother, father and their three teenage to adult children assaulting an individual. This case was significant because I had five (5) defense attorneys, and this has been my only multiple co- defendant trial. My court management skills were called into play repeatedly as I handled objections and evidentiary issues from five defense attorneys, often at the same time. The prosecutor was Lisa Weiler-Parsons and the defense attorneys were Tyrone Mitchell, Sherri Lauritano, Phillip Beatty, Matthew Leathers and Glen Allen, who is also now a superior court judge. See Attachment A.

State v. Joel Woods CR2024-006319-001. The defendant was charged with First Degree Murder for shooting and killing what turned out to be the wrong person in retaliation for one of his fellow gang members. I am including this as a significant case given the nature of the charges, and I issued a lengthy Rule 404(b) ruling in October 2024 regarding other acts evidence the State sought to introduce at trial. Rulings on murder cases always carry extra scrutiny given the severity of the charges. I included detailed facts so the parties and the appellate court would know the evidence I considered. The defendant was self-represented. I am currently managing several murder cases. The prosecutor was Daniel Fisher and advisory counsel was Jocquese Blackwell. I have included that ruling in Attachment A.

This was also bestowed at their annual fundraiser, and was in recognition for my work with minor victims of sex trafficking in STRENGTH Court. I have told them they cannot assume I had wealth or had it easy just because I am a judge. I tell them that no matter what their circumstances, if they apply themselves, the sky is the limit, and they can become anything they want.

I have been on the bench for twenty years. I have presided over aggravated DUI cases for four of those years, handling eighty (80) aggravated DUI trials. I know the City of Phoenix Municipal Court presides over DUI cases, so I believe my experience aligns very well with that caseload. In addition to presiding over approximately 170 felony jury trials, I have presided over hundreds of bench trials, which is another of the duties of a City of Phoenix municipal judge.

Superior court judges are rated every two years for a four-month period by litigants, jurors, lawyers, witnesses and court personnel such as clerks and court interpreters, and by our staff. It is called the judicial performance review or JPR for short. My JPR scores have always been excellent, and they are available upon request. I have a twenty- year record of treating everyone who comes before me with fairness, dignity, impartiality and equality, and I always uphold their due process rights to be heard. My judicial temperament and my ability to manage my calendar efficiently and effectively are reflected in those high scores, as is my knowledge of the law. I also have a stellar appellate record, which is also available upon request. That record, of course, speaks to my knowledge of the relevant law, the rules of evidence, handling evidentiary issues such as dealing with scientific evidence or expert witnesses, and all aspects of trial practice and sentencing. It spans my rotations to Criminal, Family and Juvenile departments. All this to say I am a known entity, with a proven track record, who could hit the ground running day one. The City of Phoenix Judicial Selection Advisory Board, the City of Phoenix Municipal Court bench and the citizens of Phoenix can be assured that I will be a fair, impartial and effective judge who knows the law and treats people with dignity and respect. I adhere to the rule of law. I absolutely love being a judge, and helping all those who come before me, and I plan on serving on the bench for many more years. I welcome the opportunity to serve the City of Phoenix litigants and victims with distinction, alongside all the other outstanding judges on this municipal bench.
