# Office of Accountability and Transparency Director Named



City Manager Jeff Barton has named Roger Smith as the city's first Director of the Office of Accountability and Transparency (OAT).

The Phoenix City Council first approved the new office last year, finalizing the specific duties of the office in June. This includes monitoring or investigating members of the Phoenix Police Department and ensuring complaints against officers are handled fairly and objectively.

The new office may also provide recommendations for training, policy, and disciplinary actions.

Smith brings to the role extensive experience investigating complaints of misconduct against police employees. He currently leads the Office of Professional Standards (OPS) for the city of Cleveland. This office investigates 200-300 allegations of misconduct against Cleveland police officers annually. Under his direction, the OPS works directly with the Department of Justice on dozens of provisions in the City's consent decree with the Department of Justice.

Prior to his work with Cleveland, Smith worked in New York City including nine years as Counsel for the city's Civilian Complaint Review Board.

As a University of Southern California Law School graduate, Smith previously worked as an Assistant District Attorney and as an agency attorney for the New York City Department of Corrections. He also has a B.A. in History and M.A. in Journalism from the University of Maryland, College Park.

He begins his new role on December 6.

## **Phoenix Road Safety Action Plan**

To improve safety for all users of Phoenix's roadways, the City of Phoenix is investing in a comprehensive Road Safety Action Plan that will further the city's current efforts and provide a framework and key strategies for safety enhancements citywide.

To develop the plan, staff will conduct a comprehensive evaluation of data and current conditions. The plan will consider the 4 E's: Evaluation, Engineering, Education, and Enforcement.

The Street Transportation Department is currently facilitating the public engagement phase of the process. Community members are encouraged to provide input that will help shape the plan by taking an <u>online interactive</u> survey that is available in English and Spanish.

# Phoenix Awarded Funding for Bike-to-School, Pedestrian Safety Initiatives

The Arizona Governor's Office of Highway Safety recently awarded \$25,000 to the City of Phoenix Street Transportation Department to support its ongoing bicycle and pedestrian safety programs.

The funding will be used to purchase bicycle helmets for students who participate in the city's annual bike-to-school events, as well as LED stop sign paddles for crossing guards stationed at high-traffic locations citywide.

# **Sky Harbor Holiday Travel Tips**

#### **Book ahead**

Did you know passengers can book parking up to six months ahead of their travel date? Reserve your spot at any Sky Harbor parking facilities while saving yourself time and money. Visit the parking page to check for more information.



#### Security awareness

Make sure you double check what's

in your bag and become familiar with the <u>guidelines</u> to pass through security, including items that may be restricted. View Security Checkpoint wait times on <u>skyharbor.com</u> or on flight information display boards in each terminal. Visit the Transportation Security Administration (TSA) <u>travel page</u> for more tips, or receive answers to your questions directly from TSA's <u>Twitter page</u>.

#### Save time and avoid roadway traffic with the PHX Sky Train®

Whether picking up or dropping someone off, roadways around the airport get especially busy during the holidays. Avoid the roadway and curbside congestion by utilizing the 44th Street PHX Sky Train® Station. Travelers can ride the train, free of charge, directly to and from the terminals. There are also short-term parking meters and a free cell phone waiting lot there.

#### **Check status**

Double check your <u>flight status</u> with your airline before coming to the airport, and make sure to give yourself plenty of time. Arrive at least two hours before your flight departure for domestic travel or three hours for international travel.

#### Face masks required

Face masks covering the mouth and nose are required to be worn at all times under the federal mask mandate. Make sure to be familiar with current <a href="COVID-19">COVID-19</a> protocols for all areas you visit.

District 3 Street Transportation Department Updates

Street Transportation crews have been hard at work around District 3 and citywide!

In District 3 alone, crews have completed 90.6 miles of mill and overlay work, 124.6 miles of preservation treatments, 137.7 miles of crack seal, and 2,380 ADA ramps (from July 1, 2018 to October 31, 2021).

# **MyPHX311 Mobile App Now Available**



The City of Phoenix recently announced the launch of a new service through an app called 'MyPHX311' that allows residents to pay their City Services Bill, report quality-of-life issues and request city services.

The new mobile app is a compliment to the recently upgraded version "PHX At Your Service" web portal (now <a href="Phoenix.gov/myPHX311">Phoenix.gov/myPHX311</a>). The

myPHX311 app is optimized for smartphones but can also be used on tablets as well. With this new digital interactive experience, residents can send reports directly to the City's website. The app allows community members to provide city staff with pictures, videos, descriptions, and the location when reporting an issue.

Once the app is downloaded (<a href="Phoenix.gov/app">Phoenix.gov/app</a>), users can create an account to access most of the features available. Users can also proceed as a guest. The app is also available in Spanish.

Users can search job postings, review street closures and neighborhood programs. Each item is linked directly to the <a href="Phoenix.gov">Phoenix.gov</a> website, making it easy to follow-up

on service requests and stay up to date on all the resources Phoenix has to offer. The MyPHX311 mobile app is available for download on Android and iOS.

The public should continue to report emergencies by calling 911. Emergency or urgent service requests should not be reported on the app.

To report water or sewer-related emergencies such as a broken water main, fire hydrant, or water service line (between a water meter and the street) or sewer backups, call 602-261-8000. Issues that occur outside of Phoenix's jurisdiction should be reported to the appropriate agency or organization.

## **Drought Pipeline Construction**

Construction on the 66-inch pipeline is underway and schedule to be complete in early 2023. The pipeline project that will connect to the new pump station on 31st Street south of Bell Road also began last fall. Construction for the rehabilitation/replacement 48-inch pipeline is complete. This pipeline was repaired/replaced to avoid failure of the pipe, which carries 35 million gallons of tap water a day to North Phoenix.

To help keep community members updated on construction updates and alerts, the city has launched the Pipeline Project mobile app. The free app is now available for download on your iPhone or Android's app store.
