Permit Requirements

- Provide site plans illustrating the performance area include all six zones of the performer: floor, ceiling, front, back, left and right.
- Provide a site plan illustrating the location of the fire performer, safety perimeter line, other equipment (stages, tables, ETC.) and audience locations.
- Provide proof of insurance one million dollars (\$1,000,000) each time you apply for a fire permit. The insurance form shall list the City of Phoenix as additional insured.
- Provide a Hold Harmless Agreement.
