1. The alley must be a City of Phoenix alley. The program cannot gate alleys on private property or an easement on private property.		
2. The alley must have permanent, sound fencing at least 5 feet in height along the length of the entire alley. Having temporary fencing on any portion of the alley is not eligible for the program. 3. The alley must not have extensive vehicle access and use. The program requires petition signatures of property owners with garages or carports accessed from the alley.
