Subject: IMPACT MELANOMA FREE SUNSCREEN PILOT PROGRAM

The Parks and Recreation Department, in partnership with IMPACT Melanoma, participated in a pilot program by providing free sunscreen at designated park locations during the summer seasons of 2024 and 2025. This report provides information regarding this program.

BACKGROUND

IMPACT Melanoma is a non-profit on a mission to prevent skin cancer. Through educational programs, community outreach, and partnerships with health organizations, they promote sun safety, early detection, and life-saving awareness. As part of their educational effort to prevent skin cancer, IMPACT Melanoma partnered with the City of Phoenix Parks and Recreation Department to launch a pilot program during the summer season in 2024 and 2025. IMPACT Melanoma provided free sunscreen, along with any necessary dispenser replacements, maintenance and weekly refill of the sunscreen at no cost to the Parks and Recreation Department.

In summer 2024, IMPACT Melanoma launched its first pilot program providing free sunscreen at six splashpad locations. The initiative, which ran from May 25 through October 1, aimed to promote sun safety and prevent skin cancer. Sunscreen dispensers were installed at Altadena Park (3711 E. Altadena Ave.), Margaret T. Hance Park (67 W. Culver St.), El Oso Park (3451 N. 75th Ave.), Mariposa Park (3150 W. Morten Ave.), Nuestro Park (1433 S. 9th St.), and Trailside Point Park (7215 W. Vineyard Rd.)

Over the course of the program, a total of 25,000 visitors were served with free sunscreen across the six sites. However, the initiative faced significant challenges, as frequent vandalism of the dispensers required ongoing maintenance and replacement to keep the program running smoothly. The total spent on this pilot program was \$11,931 from May 25 through October 1, 2024.

DISCUSSION

During the second year of the pilot program, from May 22 through October 1, 2025, three sunscreen dispensers were installed at both the South Mountain Visitor Center (10409 S. Central Ave.) and the North Mountain Visitor Center (12950 N. 7th St.), bringing the total to six dispensers. These units were strategically positioned at key

access points around each center to maximize both visibility and convenience for hikers and visitors.

IMPACT Melanoma continued to provide free sunscreen, along with all necessary dispenser replacements, maintenance, and weekly refills, at no cost to the Parks and Recreation Department. Over the course of the program, a total of 23,000 visitors received free sunscreen across both centers. The total expenditures for this pilot program was \$6,367.

The sunscreen pilot program has successfully concluded, with positive outcomes observed at both participating sites during the 2024 and 2025 summer seasons. This success was made possible through consistent weekly maintenance and refills. The Parks Department will pursue grant opportunities and partnerships to explore how free sunscreen can continue to be made available to the public in select parks and recreation locations.

1. CALL TO ORDER

Chairperson Dalton called the meeting to order at 5 p.m. with Board Members Bustamante, Moya, Porter, Thomas, and Viera in attendance.

Board Member Moya made the motion to approve consent items 3a through 3c. Board Member Viera seconded the motion, and the motion passed unanimously, 6-0.

4. INFORMATION AND DISCUSSION ITEMS

Information and Discussion items are presented for informational purposes only,

and no action will be taken.

4a. 24/7 Code of Conduct Answering Service Update

Deputy Director Rogers presented on the Code of Conduct Answering Service. He explained that the Department has offered a dedicated Code of Conduct phone line for approximately one year in response to public requests to report code of conduct violations on park property. In September 2024, the Department contracted with a call service provider to provide intake and distribute information to Park Rangers on duty.

Deputy Director Rogers stated callers are advised to contact 911 to report crime and emergencies taking place in a park. For code of conduct violations, the public can call the 24/7 line. Park Rangers, who are on duty 24 hours a day, review and prioritize reports and visit parks as needed, although their presence may not always be observed by the public.

He also noted that while the current service was something that could be done timely and, in a cost, efficient way, the intent was always to pilot the service and idetnify opportunities for improvement. Potential improvements include the ability to inform residents of the outcome of their call, development of a searchable database and the ability to generate reports on the types and frequency of calls received. The Department plans to issue a Request for Proposals (RFP), to seek a qualified vendor who can provide these services.

Board member Barnwell joined the meeting virtually at 5:05 p.m.

Chairperson Dalton inquired about the existing system's capabilities, specifically whether the public receives any type of notification when a Park Ranger responds to a call and whether the system allows for analysis of call themes or topics.

Deputy Director Rogers explained that the public does not currently receive any notification when a Park Ranger has responded to a call. While an automated response feature may be possible in a future system, additional resources may be needed to provide specific updates. He also noted that the existing system does not have the capability to analyze call topics.

Director Aguilar acknowledged that while other City systems provide responses to residents, those programs may have dedicated staff or additional resources to manage inquiries. The Department will explore options for an automated response feature as part of the RFP.

Board Member Bustamante emphasized the importance of ensuring any new system includes analytical capabilities and noted that the public may sometimes report perceived violations of the Code of Conduct rather than actual infractions.

Board Member Porter expressed concern about individuals using motorized bikes in parks in ways that disturb other patrons or create unsafe conditions. She inquired whether the Code of Conduct phone number is displayed on Code of Conduct signage or other signs within the parks.

Deputy Director Rogers stated that the phone number is included on park signage

Board Member Porter also asked how calls are handled when Park Rangers are off duty or when situations require involvement from the Phoenix Police Department.

Director Aguilar reminded the Board that Park Rangers now operate 24 hours a day, allowing them to respond to calls and coordinate with the Police outside of park hours. She noted that as part of the phone line campaign, the Department is educating the public about the code of conduct phone line and when residents should call this number versus the police department.

Board Member Moya requested that any future system includes the ability to track or report on response times.

Board Member Viera expressed concern about ensuring that individuals in need within the parks are offered appropriate assistance and resources.

Director Aguilar explained that Park Rangers are equipped with contact information and work closely with the City's PHX C.A.R.E.S. Team and the Office of Homeless Solutions to offer or connect individuals with available services.

Board Member Bustamante expressed interest in including an automated response feature as part of the new system.

Chairperson Dalton inquired about the anticipated timing for releasing the Request for Proposals (RFP).

Director Aguilar stated that the Department hopes to release the RFP in December or January. Once a vendor is selected and approved by City Council, an update will be provided to the Board. She added that as part of the RFP process, the Department is reviewing other City systems to potentially model an automated response component.

There was one virtual speaker for this item.

Mr. Spellman expressed the importance of having a system that updates in real time. He noted that when reporting crimes to Crime Stop, he receives an immediate text confirming the report and a follow-up message once the issue has been addressed.

5a. DISCUSSION AND POSSIBLE ACTION

Discussion and possible action items are for information, discussion, and possible action.

5a. Approval of Park Master Plan and Naming of an Undeveloped Park Site at 99th Avenue and Lower Buckeye Road

Deputy Director Joe Diaz presented on the master plan and naming of the undeveloped park site located at 99th Avenue and Lower Buckeye Road. He outlined the site's history,

location, and planned development. He explained that the property was purchased in 2002 with funding from multiple City departments and that \$8.27 million from the 2023 GO Bond program has been allocated for the park's master plan design and limited construction. The site currently includes the Estrella Precinct Police Substation, built in 2009, and a fire station added in 2024. The site includes 111 acres for park development.

Deputy Director Diaz reported that community input was gathered through two public meetings and an online survey available in English and Spanish, which received 901 responses. Residents prioritized amenities such as restrooms, a playground, a splash pad, shaded areas and sports fields, and selected Sierra Estrella Park as the official name. Based on this feedback, a master plan was drafted and approved by 92 percent of respondents. Renderings and concept plans were presented, with construction planned in multiple phases due to the park's size and funding requirements. The first two phases will complete the master plan and develop the east side of the park in coordination with the new library, while later phases, which are currently unfunded, would include the remaining park areas and a community center. Phase one is anticipated for completion between 2027 and 2028.

Board Member Moya asked about the inclusion and location of a splash pad within the Sierra Estrella Park master plan.

Deputy Director Diaz explained that the master plan includes a misting station located on the west side of the park, which is planned for completion in future phases.

Director Aguilar explained that the current GO Bond funding covers only the design and development of about one-third of the park. She noted that residents have identified a lack of sports fields as a key concern and that the City's long-term plan is to return to voters every five years to seek additional bond funding for future phases, including development of the east side of the park and the splash pad.

Board Member Moya asked about the proximity of the nearest splash pad and the type of community center planned for the park.

Director Aguilar stated that the nearest splash pad is located at Trailside Point Park and that the planned community center would be similar in design and function to the Cesar Chavez Community Center.

Board Member Porter observed the lack of public comment at the meeting and asked if the Department had any insights into why community members were not present for the discussion.

Director Aguilar stated that the community appears to be well aligned in their vision for the park and likely felt their input had been adequately heard and incorporated during the master plan outreach process.

Board Member Bustamante commended staff for achieving a high level of community approval for the master plan and expressed appreciation for the Department's efforts to minimize the impact of sports lighting.

Board Member Moya asked if the Department was aware of how the Public Works Department planned to use its portion of the property and emphasized the importance of incorporating shade and appropriate building materials into the design.

Director Aguilar explained that while the Public Works Department had not provided any specific plans, the site would likely include space for storage and maintenance of fleet vehicles. She added that shade is always a core consideration in park design and is most effectively incorporated early in the planning process.

Board Member Viera asked whether specific components of the park could change as future phases are developed and inquired why certain priorities identified in the public survey were not included in phase one.

Deputy Director Diaz responded that the Department intends to follow the approved master plan as closely as possible, though some spacing and layout adjustments may occur during construction.

Director Aguilar added that full completion of the parks design will reflect the community's priorities, however the park will be designed in a way that enhances cost efficiencies so all amenities can be built.

Director Aguilar also noted that while the identified GO Bond funding will fund design and construction of a portion of the park, but not 1/3 as originally estimated due to design and construction costs. The park will need to be constructed in multiple phases.

Board Member Moya moved to approve the master plan and the park name, Sierra Estrella Park. Board Member Bustamante seconded the motion, and it passed unanimously, 7–0.

6. CALL TO THE PUBLIC

Julia Taggart thanked staff for their support of a recent festival at the North Mountain Visitor Center and encouraged the Board and members of the public to visit the center, noting that it is operated by dedicated volunteers.

7. BOARD CHAIRPERSON'S REPORT

No report.

8. BOARD COMMENTS/REQUEST

No comments.

9. DIRECTOR'S BRIEFING

Assistant Director Barrett highlighted the Butterfly Release Event held at Rio Salado on September 27, where volunteers helped clean the park and remove invasive species before and during the release. Attendees were able to experience butterflies landing on

them or gently holding one on their finger, creating a memorable and engaging community event.

Assistant Director Whitfield recapped several Halloween-themed events, including the Festival of Frights at South Mountain Park and Preserve and Scaryvale at Maryvale Park and Community Center. He also noted the success of the Phoenix Pride Festival and Parade at Steele Indian School Park, which featured food vendors, art displays, youth and VIP areas, and community showcases that celebrated and promoted visibility for the Phoenix LGBTQ+ community.

Director Aguilar provided updates on the Department's Master Plan efforts, announcing eight upcoming community meetings to reach areas with lower participation and ensure citywide representation. She also shared information about the upcoming ribbon-cutting ceremony for Eastlake Park Pool, the first inner-city pool to include a heater. This feature will allow extended aquatics programming and open swim through November, serving as a pilot to assess community interest in fall and winter aquatics services.

Subject: 2026 PARKS AND RECREATION DEPARTMENT REQUESTS TO VEND

This report requests Parks and Recreation Board (Board) approval of vending requests at various park locations for the upcoming 2026 events.

BACKGROUND

City of Phoenix parks are reserved throughout the year for various public events. Event coordinators or community partners produce many of the events, and the department sponsors several community events. Some events are free to the public, while others require registration or an entrance fee. Event producers who rent city parks and facilities are required to follow all city guidelines, including obtaining all applicable permits and licenses.

Vending, a typical component of events in parks, can consist of selling admission and food and beverages, t-shirts, or other concessions for fundraising purposes. Per the Phoenix City Charter and Phoenix City Code 24-40, the Parks and Recreation Board must grant approval for requests for vending in parks. Due to the high volume of events in city parks on an annual basis, and the popularity of vending, it is the practice of the Parks and Recreation Department to bring an annual request to vend report to the Board each year in November that contains all known events that are anticipated to take place the following year.

This report may not be all-encompassing, as events and requests to vend occur at any time during the year, and staff may request Board approval for new events as they arise.

DISCUSSION

The annual vending report for 2026, contained in *Attachment A*, features cultural awareness events, athletic events, festivals, and a variety of other events that promote positive community awareness and engagement for a wide array of ages and abilities. All City guidelines and requirements for sales, permits, and licenses are required to be followed by producers and groups who rent parks for their events.

This report contains all known events anticipated to take place in 2026. Any additional event vending requests not currently known will be presented to the Board independently.

RECOMMENDATION

Staff recommends Parks and Recreation Board approval to vend at various park locations for potential events, as listed in Attachment A.

REQUEST AUTHORIZATION TO ISSUE SMALL RECREATION

Subject: CENTERS REQUEST FOR PROPOSALS

This report requests Parks and Recreation Board (Board) authorization for staff to issue a Request for Proposals (RFP) for the operation and maintenance of the small recreation centers at Barrios Unidos Park located at 1501 E. Mohave Street; Smith Park located at 4030 W. Sherman Street; and Green Valley Park located at 1401 E. Watkins (**Attachment A**).

BACKGROUND

The Parks and Recreation Department previously operated recreation centers located at Barrios Unidos, Smith and Green Valley Parks. Due to budget reductions, these centers were either shuttered or operated by non-profit partners over the years. Currently, while outdoor recreation programs and activities take place at Barrios Unidos and Green Valley Parks, the indoor recreation centers are not open to the public. The Smith Park recreation center was being operated by a non-profit through September 2025, when the agreement was cancelled.

DISCUSSION

These recreation centers have the potential to serve as meaningful hubs for the community. The Department seeks to issue competitive RFPs to identify one or more qualified nonprofit organizations to manage the day-to-day operations and provide recreational/educational programming at these locations. If approved, the RFP for Barrios Unidos Park and Smith Park are planned to be released by no later than January 2026. The Green Valley Park RFP is planned to be released by February 2026 due to scheduled maintenance and repairs.

Each solicitation and selection process is expected to take approximately four months. Upon completion, the successful proposer(s) will enter into a contract for an initial three-year term, with 1 two-year option, and 1 additional five-year option, for a total of 10 possible years. The third-party operators(s) will be responsible for paying market rent and for the cost to operate and maintain the recreation center(s). The Department will ensure the community surrounding each of these recreation centers are engaged and aware of the upcoming solicitations and will include a minimum of one community member in the RFP proposal review process.

RECOMMENDATION

Staff requests Board authorization to issue RFPs for the operation and maintenance of the recreation centers at Barrios Unidos Park located at 1501 E. Mohave Street; Smith Park located at 4030 W. Sherman Street; and Green Valley Park located at 1401 E. Watkins.

Subject: PARKS MASTER PLAN UPDATE

This report provides the Parks and Recreation Board (Board) an update on the Parks Master Plan process.

BACKGROUND

The Parks and Recreation Department is in the process of developing a comprehensive Parks Master Plan that will serve as a strategic guide for the long-term growth and sustainability of the City's park system. This plan will outline strategies for enhancing existing parks, improving recreational facilities and developing undeveloped parklands. It will also evaluate opportunities to introduce new amenities and programs that meet the evolving needs of the community. Furthermore, the Master Plan will integrate water conservation measures and incorporate crime prevention strategies, with a strong commitment to advancing equity and inclusivity across all parks citywide. The City's last comprehensive Parks Master Plan was completed in 1988.

DISCUSSION

The Parks Department has been actively engaging the community through a variety of outreach tools, including adult and youth surveys, an interactive feedback map, statistically valid surveys, dot-vote boards, and other engagement methods. This report presents to the Parks and Recreation Board a summary of the assessment findings, the results of these community engagement efforts, and key insights derived from outreach to date. The analysis highlights both strengths and areas for improvement, providing a foundation for future planning, policy direction, and investment decisions. The information is intended to inform and guide the next phases of the Parks Master Plan.

The City's parks system demonstrates numerous strengths that make it a valuable community resource. Many parks feature unique characteristics that reflect the identities of their surrounding neighborhoods, fostering a sense of place and cultural connection. Functional spaces throughout the system are well-utilized and designed with flexibility in mind, supporting a wide range of recreational and social activities. The system also provides opportunities for community gatherings, with a mix of social and programmatic spaces that encourage interaction. Several sites benefit from mature shade canopies

and establish natural features, enhancing both comfort and usability. Additionally, the park system offers a diverse array of recreational amenities, promoting active lifestyles and catering to a broad spectrum of community interests.

Despite these strengths, the system faces several areas for improvement. Many park assets and amenities have reached or surpassed their useful life, requiring replacement or significant rehabilitation. Access and connectivity remain a challenge, with gaps in pedestrian pathways that reduce usability for residents. Safety and visibility concerns persist, including inadequate lighting and obstructed sightlines, all of which affect public perception and use of parks. Increased shade continues to be key to increase comfort during peak usage. Supporting assets such as restrooms, lighting, and furnishings frequently require repair or replacement to meet community needs and expectations.

Community engagement played a central role in the development of this Master Plan. The process employed a multi-layered strategy, combining online tools, surveys, inperson conversations, and interactive mapping to capture input from a broad cross-section of Phoenix residents. Participation included 59 in-person meetings with 407 participants, 7,355 responses to the general community survey, 590 youth survey responses, 4,505 contributions to the interactive mapping tool, 5,532 dot-votes collected through "Dot-o-cracy" exercises, and 1,133 statistically valid household surveys. In total, thousands of community members engaged in the planning process, ensuring representation across diverse age groups, neighborhoods, and cultural backgrounds.

Several key themes emerged from community input, shaping the Master Plan's direction. Residents emphasized a "Fix-It-First" approach, prioritizing maintenance, lighting, cleanliness, and restroom upgrades. The need for shade was highlighted, with calls for expanded tree canopy and built structures throughout the system. Everyday use and family-oriented activities were identified as priorities, with an emphasis on parks that support daily recreation. Community members also underscored the importance of safety and activation, advocating for improved lighting, thoughtful design, and programming to enhance security. Finally, there is clear demand for strategic investment in recreational facilities, including aquatics, dog parks, and sports courts. These findings provide a foundation to guide capital investment and policy decisions in the implementation phase of the Master Plan.

The next steps in the planning process will focus on operationalizing these priorities. A level-of-service analysis will identify access gaps and inform strategies to improve equity and convenience. Detailed capital improvement prioritization will align investments with demonstrated need, equity considerations, and operational sustainability. The Department will also establish a long-term operational and maintenance framework to address funding, staffing, and lifecycle reinvestment. Finally, a comprehensive draft of the Master Plan will integrate system analysis, community priorities, and implementation strategies for public review and Board consideration.

The City's parks system ranks among the largest and most diverse in the nation. The Master Plan update reflects the community's strong pride in its parks, as well as a clear commitment to their protection, maintenance, and enhancement for everyday use. Throughout the planning process, community members have consistently emphasized three priorities, preserving existing assets, improving safety and comfort, and expanding access to essential recreational opportunities. This guidance will shape the Department's investment priorities and operational decisions over the next decade.

Subject: UPDATE ON THE PILOT AND REQUEST FOR APPROVAL TO

PERMANENTLY TRANSITION MANAGEMENT OF ARTS AND

CULTURAL FACILITIES FROM PARKS AND RECREATION TO THE

ARTS AND CULTURE DEPARTMENT

This report requests Parks and Recreation Board (Board) authorization to permanently transition the facility management of five cultural facilities previously managed by the Parks and Recreation Department (Parks Department) to the Arts and Culture Department.

BACKGROUND

The Parks Department values its long-standing partnerships with arts and culture organizations that bring creativity and service to the community. Many nonprofit partners have continued programs in Parks facilities during times of limited city funding, helping keep these community spaces open and active.

In 2024, Parks and the Arts and Culture Department identified three nonprofit organizations that provide programming in four city-owned facilities, as well as the city-owned and operated S'edav Va'aki Museum. Each organization has a unique operating agreement and distinct programming. The goal is to move these facilities under the direct oversight of the Arts and Culture Department to strengthen coordination and support.

Phoenix Center for the Arts

Operated by the Phoenix Center Arts Association

Located at 1202 N. 3rd Street, the Phoenix Center for the Arts offers more than 300 classes each year and hosts events such as the Phoenix Art and Wine Festival. It provides bilingual options and a variety of arts and cultural programs. The center operates under a Management and Operating Agreement between the City of Phoenix and the Phoenix Center for the Arts Association. The current 10-year agreement began in November 2017 and will expire in October 2027.

Phoenix Center for the Arts Thunderbird Teen Center

Operated by the Phoenix Center Arts Association

Located at 1104 E. Grovers, the Thunderbird Arts Center provides year-round art classes for youth and adults. Programs include ceramics, mosaics, painting, drawing, photography, printmaking, and youth art. The two-story ADA-compliant facility includes classrooms, offices, a game room, and outdoor spaces. The Parks Board approved a 5-year agreement in January 2016 with an option to extend for another 5 years, effective through January 2026.

Tovrea Castle

Operated by the Tovrea Carraro Society

Located at 5025 E. Van Buren Street, Tovrea Castle is a historic landmark built in 1928 by Alessio Carraro. The castle became city property in 1993. In 2011, community volunteers formed the Tovrea Carraro Society to open it to the public. The Parks Board approved an operating agreement with the society in 2011, followed by a 10-year renewal in 2016 with two 5-year extension options. The current agreement expires in October 2028, with potential extensions through October 2038.

Shemer Art Center

Operated by the Shemer Art Center and Museum Association

Located at 5005 E. Camelback Road, the Shemer Art Center provides art classes, exhibits, and a sculpture garden. Professional artists teach drawing, painting, ceramics, fused glass, and more. The center also has a boutique shop featuring local art. In 1984, Martha Shemer donated the property to the City of Phoenix. The Parks Board approved an operating agreement in 2010, renewed in June 2020 for ten years, with an option to extend for another ten years following a five-year review.

S'edav Va'aki Museum

City Operated

Located at 4619 E. Washington Street, the S'edav Va'aki Museum sits on an archaeological site that highlights Ancestral O'Odham (Hohokam) culture. The museum offers exhibits, programs, and amenities such as free Wi-Fi, picnic areas, and a museum store. In 2023, the Parks Board approved renaming the museum from the Pueblo Grande Museum to honor the O'Odham and Piipash tribes. The S'edav Va'aki Museum Foundation supports fundraising efforts.

DISCUSSION

The Arts and Culture Department serves as the City of Phoenix's local arts agency. It promotes and supports the arts through grants, education, public programs, and cultural management. The department already manages eight cultural facilities, including the Arizona Opera Center, Ballet Arizona, Children's Museum of Phoenix, Gallery @City Hall, Helen K. Mason Center, Phoenix Art Museum, Phoenix Theatre, and Valley Youth Theatre.

Since assuming management of these facilities in 2018 from the Public Works Department, the Arts and Culture Department has demonstrated success in facility oversight and collaboration. The department secured 10 percent of the \$500 million General Obligation Bond approved by voters in November 2023 and has invested more than \$4.5 million in facility improvements.

Moving these facilities under the Arts and Culture Department offers several benefits:

- Centralizes arts facilities and creates a network of nonprofit partners with shared goals and challenges
- Provides an advocate through Arts and Culture, which already offers grants and support services
- Ensures one dedicated property manager for all arts facilities, responsible for inspections, maintenance, and coordination

- Offers stronger technical assistance, staff support, and resources for programming, governance, and fundraising
- Includes these facilities as potential priorities in future bond programs and capital improvement plans

The S'edav Va'aki Museum will remain city-operated but will benefit from being part of the local arts agency network. The museum staff will gain access to grant opportunities, partnerships, and technical support. The museum also houses the city's archaeology office and repository, which align closely with Arts and Culture's expertise in museum management and preservation.

In the past year, Arts and Culture has achieved several milestones:

- Installed new fencing around the S'edav Va'aki Museum and the Parks of Four Waters
- Replaced exterior doors at the Shemer Art Center to improve security while preserving historic design
- Secured funding to add air conditioning to the upper floors of Tovrea Castle and for new perimeter fencing
- Managed a \$1.19 million bond project to upgrade the Third Street Theatre at the Phoenix Center for the Arts

The partnership between Arts and Culture and Parks is highly collaborative, as evident in recent joint projects, including new public art installations in various parks, such as the two most recent skate projects at Perry and Solano Parks. Arts and Culture's Neighborhood Arts Program funded ten art projects in various parks throughout the city before the pandemic, and with grantmaking, Arts and Culture assisted with the Parks and Recreation's ARPA Park Activation Neighborhood Grant Program application process. And most recently, the Sombra public art project was just completed. For this project, Bloomberg Philanthropies selected Phoenix as one of eight cities for a \$1 million grant for its Public Art Challenge. This unique program supported nine temporary art installations in neighborhood parks throughout Phoenix, addressing urban heat.

With Board approval, Arts and Culture and Parks will develop a final Memorandum of Understanding (MOU) outlining roles, budgets, and responsibilities for these facilities. Updates to existing operating agreements may be needed, but most list the City of Phoenix as the responsible party, ensuring a smooth transition.

RECOMMENDATION

Staff requests Board authorization to permanently transition the facility management of the five cultural facilities previously managed by the Parks Department to the Arts and Culture Department.

... . ANNUAL ELECTION OF PARKS AND RECREATION BOARD CHAIR -

Subject: NOVEMBER 17, 2025

This report recommends the presiding Chairperson conduct the annual nomination and election for the 2026 calendar year Parks and Recreation Board Chairperson.

BACKGROUND

The board adopted revised Rules of Procedure during the April 22, 2010, meeting. According to Procedure I. B.:

"Elections shall be held annually at the regularly scheduled November Board meeting to select a Chairperson from eligible candidates. The Board must either elect a new Chairperson or extend the term of the existing Chairperson. If the Board does not meet in November, the election shall take place at the first Board meeting after December 1. The new Chairperson shall assume the position of Chairperson at the first meeting of the new calendar year. A Board member is considered eligible if the Board member has served on the Board for at least one year.

No person may serve as Chairperson for more than two consecutive one-year terms. However, the Chairperson may serve three consecutive one-year terms if approved by a unanimous vote of the entire Board."

DISCUSSION

According to *Robert's Rules of Order*, 14th edition, "nominations from the floor" is a common procedure used when a nominating committee is not recommending a candidate(s).

Under the procedure of nominations from the floor, the Chair calls for nominations by saying, "Nominations are now in order for the office of Chairperson of the Parks and Recreation Board." When the presiding Chair has called for nominations from the floor, a member may make a nomination as follows:

MEMBER: Mr./Madame Chairperson, I nominate Board Member A. for the office of Chairperson.

CHAIRPERSON: Board Member A. is nominated, are there any further nominations from the floor?"

The presiding Chair repeats each nomination in this way until all nominations for the office have been made. After nominations have been closed, voting for the Chairperson takes place. Candidates will be voted on in the order in which they were nominated. The winning nomination must carry at least a simple majority of the voting members. The presiding Chair casts a vote in the same manner as the voting members.

Nominations and voting continue until a member is elected with a majority of the voting members. Voting will be by voice acclamation unless a roll call vote is determined. Voting will be properly recorded in the minutes.

RECOMMENDATION

This report recommends the presiding Chairperson conduct the annual nomination and election for the 2026 calendar year Parks and Recreation Board Chairperson.
