RE: MINOR AMENDMENT OF ALGODÓN CENTER PUD (Z-19-F-00-5) AREA GENERALLY BOUNDED BY 91ST AVENUE, 99TH AVENUE, THOMAS ROAD TO CAMPBELL AVENUE

Dear Ms. Boos,

I have had the opportunity to review your request for a Minor Amendment to the Algodón Center PUD (Ord. G-6483) that you submitted on behalf of John F. Long, LLP. You have requested changes to the design standards regarding the approved planting list and percentage of ground cover and turf in the landscape standards section. You also submitted updated Streetscape Concept exhibits to reflect your proposed changes.

Section 671 Planned Unit Development of the Phoenix Zoning Ordinance, states that amendments not meeting the criteria for a major amendment shall be deemed to be a minor amendment and may be administratively approved by the Planning and Development Director.

Upon review of this material and through consultation with other Planning and Development staff, I have determined that this request is a reasonable modification to the existing PUD ordinance and I therefore approve the amendment described herein. An updated Development Narrative for the Algodón Center PUD reflecting the changes approved through this request shall be submitted to the Planning and Development Department within 30 days of the approval of this request.

This minor amendment shall be approved, subject to the following changes as indicated in red:

1. Modify the General Landscape Requirements entry of the Landscape Standards Table (Section G, pg. 11) with the following revised language.

LANDSCAPE STANDARDS (design guidelines in italics			
General Landscape Requirements	See Exhibits 12.0 to 12.2 for general layout, and locations.		
	 Individual lot landscape designs are part of a larger landscape character instead of stand-alone statements. No design should dominate the landscape. Instead, the landscape of individual lots should interweave with Common Areas to give Algodón a sense of place. 		

- 3. All portions of the development site not occupied by buildings, structures, vehicle access and parking areas, loading and unloading areas and approved storage areas shall be landscaped in accordance with the provisions of this Section. Future building pads within a phased developed Lot may continue to be farmed, improved with temporary landscaping along the street frontage, or otherwise maintained in a dust free manner.
- 4. No part of any Landscape Area shall be used for any other such use as parking or display, except for required on site retention areas or when such use is shown on the landscape plan.
- 5. All plant materials shall be planted so that at maturity the edge of the plant will be no closer than three (3) feet to any fire hydrant or fire suppression device.
- 6. All mechanical equipment, electrical meters and similar utility devices shall be screened from public view with appropriate plantings.
- 7. All plant materials shall be irrigated by an appropriate automatic underground irrigation system. All irrigation systems shall be designed, constructed and maintained to promote water conservation and prevent water overflow or spray onto Streets, sidewalks or parking areas. Landscape irrigation and domestic water services to each site shall be metered separately. Each irrigation service point of connection shall have a reduced pressure back flow prevention device installed and maintained in accordance with the requirements of the City of Phoenix or approved equivalents.
- 8. A minimum of seventy-five percent (75%) fifty-percent (50%) of all landscape areas at maturity shall be planted with living shrubs, vegetated ground cover, and/or turf.
- 9. Turf area shall be limited to a maximum of 40% 30% on all streetscapes.
- 2. Modify the Shrubs, Groundcovers, and Accents entries in the Approved Planting List Table (Section G, pg. 14-15) with the following revised language.
