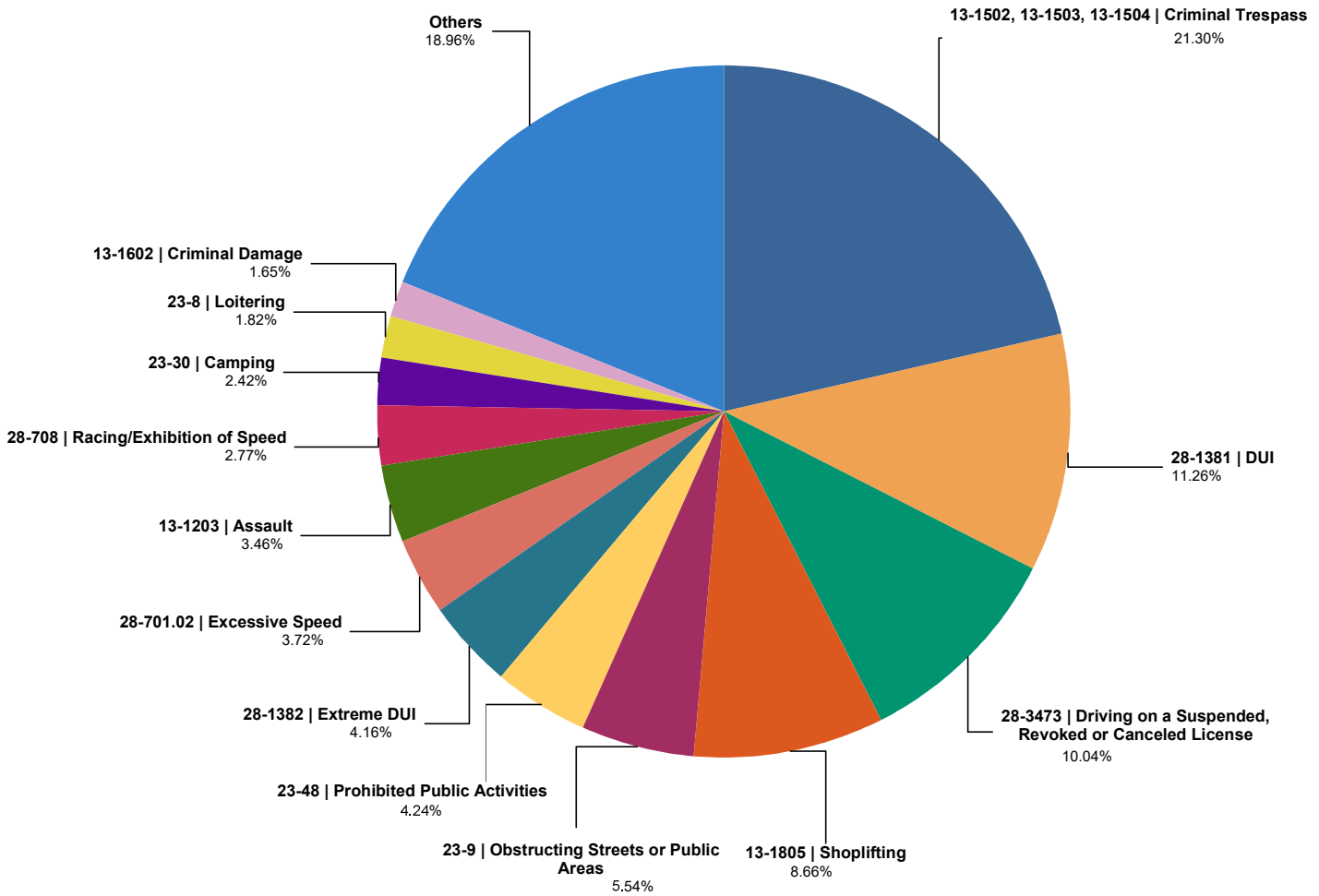




Top Misdemeanor Charges on Citation in Lieu of Detention (CLD)
