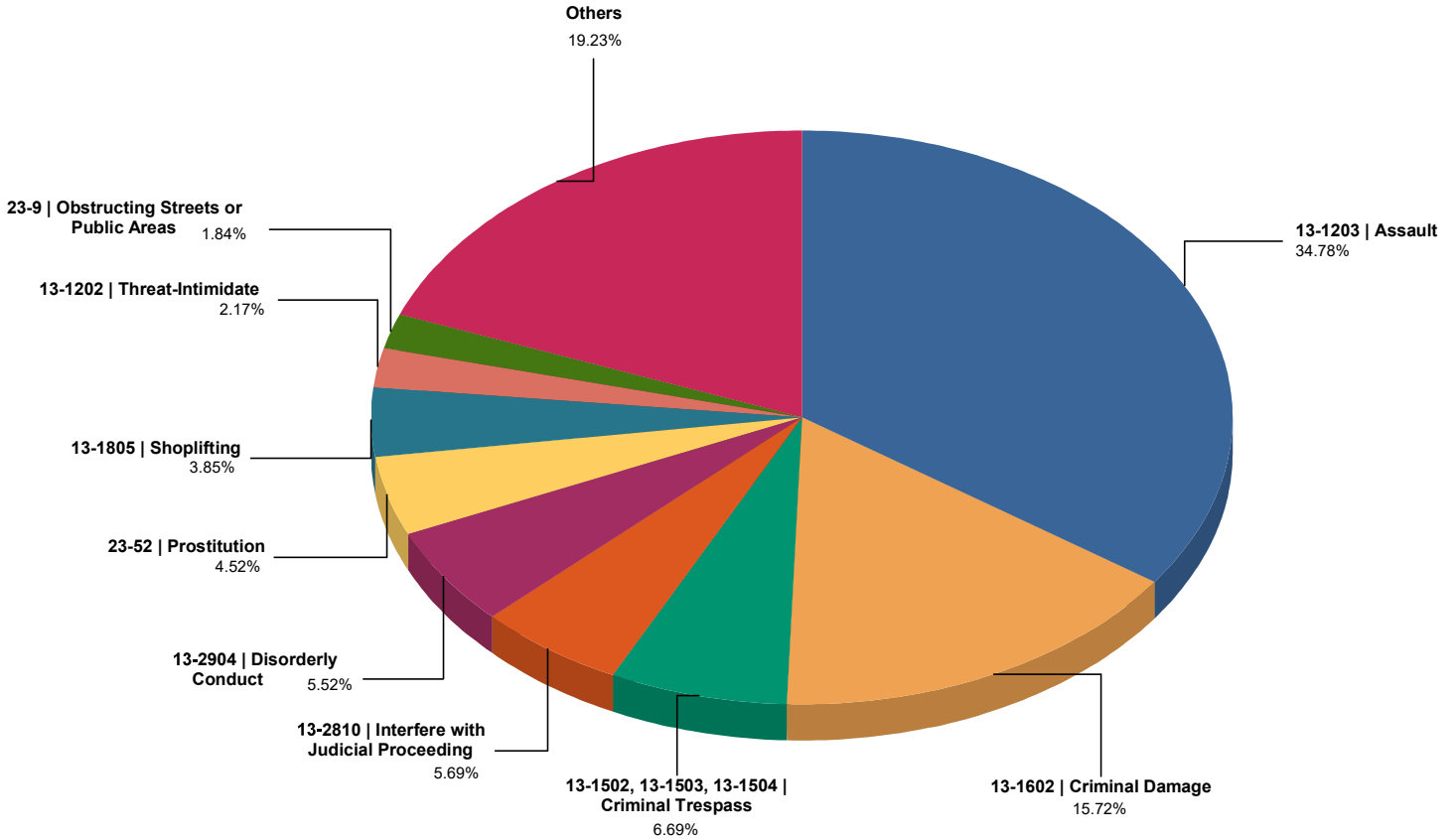




**Top Misdemeanor Adult Booking Charges**
