AUCR SRS Homicide counts in this report include UCR murder, nonnegligent manslaughter and manslaughter by negligence.

Uniform Crime Reporting Summary Reporting System (UCR SRS) counts should not be compared with Arizona Revised Statute (ARS) numbers or with UCR National Incident-Based Reporting System counts.

It is important to note that a variety of factors can affect crime counts in addition to actual changes in the level of crime. For example, changes in FBI definitions of crime categories, changes in sworn staffing numbers that affect officer on-view activity levels, changes in citizen reporting practices, changes in computer algorithms that are utilized to auto-categorize crimes, changes in record management systems (RMS), changes in proportions of reports manually reviewed vs. computer-reviewed, etc., can all affect crime counts. This is regardless of whether or not crime levels have actually changed. These types of outside factors should be kept in mind when comparing crime trends across years.

Note that some law enforcement agencies choose to include arson in the UCR SRS Part One Property Crime totals. If arson is included, then the total for 2022 UCR SRS Part One Property Crime counts is 47,787.
