PEDESTRIAN SAFETY AWARENESS

IN THE MONTH OF OCTOBER, <u>AND YEAR-ROUND</u>, STAY SAFE BY FOLLOWING THESE IMPORTANT DRIVER AND PEDESTRIAN GUIDLINES:



Safety tips for drivers:

- Always look for pedestrians everywhere and at all times
- When driving in conditions that limit visibility, like during bad weather or at night, use extra caution
- Always be prepared to stop, and always slow down when turning or entering a crosswalk
- Never pass a stopped vehicle at a crosswalk there may be people who are crossing that you are unable to see
- Always yield to pedestrians in crosswalks and make sure you don't encroach on a crosswalk
- The speed limit is not a suggestion it's the law.
 Don't speed and be aware of people, especially in walkable areas like school zones or neighborhoods

Safety tips for pedestrians:

- · Follow all signs and signals of the road
- · Walk on sidewalks whenever possible
- When sidewalks are unavailable, always face traffic and walk as far away as possible from traffic
- Use crosswalks or intersections when crossing the street
- When crosswalks are unavailable, wait for a gap in traffic and locate a well-lit area to cross
- Watch for cars entering or exiting driveways, entryways, parking lots and other car-focused road zones

Phoenix Streets & ASU Present Cool Pavement Findings

The City of Phoenix Street Transportation Department partnered with the Rob and Melani Walton Sustainability Solutions Service at Arizona State University to evaluate the effectiveness, performance, and potential co-benefits of the new CoolSeal 2.0 pavement coating. The City of Phoenix joined ASU researchers at Burton Barr Central Library to present the results of the most recent research phase

Automated Enforcement Approved

Recently, Phoenix City Council approved the Automated Enforcement Safety Program as part of the Citywide <u>Vision Zero Road Safety Action Plan</u>. The program will add fixed red light running cameras to ten intersections in Phoenix in its first year. The program will also include four mobile vehicle and four portable tower speed enforcement cameras.

The program is aimed to change driver behavior, supplement traffic enforcement efforts by Phoenix Police, and complement the City's other Vision Zero strategies. When operational, the program will include a 30-day warning period where violators will be sent warning notices in lieu of citations. The City will conduct an awareness campaign to educate the public on roadway safety in an effort to change driver behavior and meet the program goals to reduce speeding, reduce red light running, and reduce the number of collisions and their severity.

As the first step in launching the program, the Street Transportation Department will issue a Request for Proposals (RFP) by spring 2025. The program is anticipated to be operational by fall 2025.

Human Trafficking Awareness (OHS100)


Total time: 33 mins


WELCOME TO THE TEAM!














Please continue to use the Employee Appreciation and Recognition Program to acknowledge great work. The next kudos drawing will take place in January at one of the safety meetings.
